13	1. INTRODUCTION		
14	Pursuant to Sammamish Municipal Code ("SMC") 20.10.080 and Interim Public		
15	Works Standards (PWS) 10.180, the Kempton Downs Community Organization hereby		
16	appeals the City of Sammamish Department of Community Development's April 10,		
17	2015 Notice of Street Variation Approva	al for the Conner-Jarvis Subdivision -	
18	PSUB2014-00165. A copy of the Street Variation Approval and Notice is attached.		
19	2. APPELLANTS		
20	Appellant is the Kempton Downs Community Organization, a Washington non-		
21	profit corporation consisting of the homeowners within the Kempton Downs subdivision,		
22	located immediately adjacent to the Applicant's proposed subdivision. Appellant and its

members will be aggrieved and adversely affected by the Variation as it would increase traffic and create a new thoroughfare through their neighborhood.

3. GROUNDS FOR APPEAL

Kempton Downs appeals the City's issuance of this Street Variation for the following reasons:

- 1. The Street Variation is not consistent with the Interim Public Works Standards at PWS 15.010 *et seq.*, and is erroneous and/or arbitrary and capricious.
- 2. The Street Variation violates PWS 10.170 and 15.100 as it is not based on the information, plans, data or other evidence in the record.
- 3. There is no actual evidence that the reduction in pavement and loss of parking on 232nd Ave. SE is outweighed by a reduction in speed and stormwater impacts as stated by the Public Works Director's decision.
- 4. The Variation will eliminate at least five (5) homeowners' street parking due to the creation of a new street (Road C) and intersection in the Kempton Downs subdivision.
- 5. The Variation will create unsafe conditions for pedestrians and automobiles walking or traveling along 232nd Ave. SE due to the increased traffic (over 650 trips per day) flowing through the Kempton Downs subdivision from the proposed development.
- 6. The Variation will increase the pedestrian exposure at the Road C crossing and increase the existing impervious surface.
- 7. The Variation is not based on Sound Engineering Judgment as required by PWS 10.170 and PWS 15.100.

- 8. The Variation favors the economic interests of the applicant by avoiding street and pedestrian safety improvements, stormwater and environmental improvements and other requirements of PWS 15.100, and is not in the best interest of the public as required by PWS 10.170.
- 9. Notwithstanding King County and the City's zoning amendments since the Kempton Downs subdivision was created, a plat alteration of the Kempton Downs subdivision with the requisite notice to all homeowners is required based upon the proposed change of use of Tract C of the Kempton Downs subdivision.
- 10. The Variation is not consistent the City's Comprehensive Plan Transportation elements including, but not limited to, TP-3.1.5 (requiring improving substandard roadways while adding new roadway connections) and TP-3.1.6 (requiring roadway improvements not impair the safe and efficient movement of pedestrian and bicycle traffic).

4. RELIEF REQUESTED

Appellants request the Street Variation be reversed and either denied or remanded to the City for inclusion of additional conditions.
